You need a recognised undergraduate Bachelor of Commerce degree (or equivalent NQF-7 qualification) which includes financial reporting/accounting at a non-CA stream level or above. Your undergraduate degree does NOT need to be SAICA accredited.

The programme allows you to continue your studies and complete a SAICA accredited PGDA with the goal of ultimately qualifying as a Chartered Accountant.

Alternatively most businesses have a significant need for accountants and managers with strong accounting backgrounds. The bridging programme gives you an advanced level of knowledge to boost you career and CV. Some career options include:

& Qualification structure

The programme is divided into 3 study units which include material from each of these four core subject areas:

- Financial reporting
- · Management accounting and finance
- Auditing, governance and ethics
- Taxation

Completing each unit in 5 weeks means you will finish the programme in 6 months, completing each unit in 10 weeks means you will finish the programme in 12 months.

All 3 study units include material from each of the four core subject areas.

The programme provides comprehensive video lectures and tutorials, summary notes and past exam practice questions for each subject.

You will need to upload a practice question each week which is based on a past test or exam question. There is an assessment at the end of each study unit to give you feedback on your progress. There is also mock exam at the end of Unit 3 to help you prepare for the final exam.

There are two opportunities each year to write the final exam, either in June or November.
