#### Module descriptors

#### Year 1

#### **Business English**

The aim of this module is to provide students with an understanding and practical knowledge of the business communication skills essential to any business venture.

#### **Computer Skills**

The aim of this module is to provide practical use of computer applications to create, manage and format data by developing word-processing, spreadsheet and presentation skills in a Windows Operating System (OS) environment.

#### Critical Reasoning

The aim of this module is to facilitate the acquisition of the capabilities needed to think critically. These include identifying and analysing arguments, logical fallacies and the language used. In addition, the module also aims to apply these skills to specific disciplines.

#### **Economics 1A**

The primary aim of Economics 1A, which is an introductory module to Microeconomics, is to develop the competency of students to demonstrate analytical skills in different fields of basic economic principles. The module provides a framework within which the student can develop a critical understanding of the workings of a market economy and the way in which it affects individuals and institutions operating within such a system.

#### **Economics 1B**

This module introduces students to Macroeconomics. which is a sub-field of Economics. Economics is essentially the study of scarce resources at the national level and at the level of business. As a field of study, macroeconomics focuses on economics at the national level and related matters, such as economic development, the state of a country's economy, gross domestic product (GDP), fiscal and monetary policy, the role of government in the economy, economic objectives, global economic issues and economic growth factors.

#### **History 1**

The aim of this module is to introduce you to some of the most significant phenomena in human history and how these phenomena apply to Africa. The module also aims to introduce you to some of the principles of how to study history.

#### Introduction to Law 1A

The aim of this module is to provide you with the basis for your legal studies by introducing you to the background of our legal system, with an understanding of how legislation is created and introduced as law, the importance of our constitution as well as exposure to the foundations of the law. Within this module, we will discuss the different sources of our legal system and the operation of the law within society.

#### Year 3

#### **Economics 3A**

The aim of this module is to provide students with an understanding of the economic factors that affect the labour market in South Africa. Students will learn about the concepts of labour economics, such as supply and demand, wages, unemployment, and discrimination. They will also learn about the government policies that affect the labour market, such as minimum wage laws, unemployment insurance, and affirmative action.

#### **Economics 3B**

The aim of this module is to introduce students to international economics. Students will gain deep knowledge/skills on major issues that influence international trade. Students will acquire sound knowledge on the economic issues that make a country interact with the rest of the world. A substantial part of the course is dedicated to the examination of efficient trade policies, economic integration as well as the effects and motives of direct foreign investments. Knowledge of this course will broaden students' understanding of events in the world's economy and related policy issues.

#### **Entrepreneurship in Humanities**

The aim of the Humanities Entrepreneurial module is to empower students with the essential knowledge, skills, and mindset to initiate, develop, and sustain entrepreneurial ventures rooted in humanities. This involves integrating principles from both the humanities and business domains, illustrating how critical thinking, effective communication, and cultural awareness can drive entrepreneurial success. Through practical instruction, students will gain proficiency in key entrepreneurial practices such as business planning, market analysis, financial management, and networking. Moreover, the module aims to cultivate a spirit of lifelong learning, enabling students to navigate changing market landscapes, emerging technologies, and evolving societal demands with agility and adaptability

#### Law for Psychology Students

This module aims to provide a broad perspective of the intersection of psychology and South African law. This overview will be achieved by studying the practical and theoretical intersections of the two fields. In this course, you will be introduced to how psychological principles can be applied to legal issues in the 'real world'. A range of topics will be covered, including crime policing, psychological assessment for the courts, custody of children, evidence given by expert witnesses, the functioning of the South African legal system, and its intersection with psychology.

#### **Political Science 3A**

The aim of this module is to provide you with the understanding, insight and skills relevant to the study of international relations. The module provides insight into the relations among states within the international system and issues dominating international politics.
