WHAT IS DISTANCE SELF PACED (DSP) MODE AND WHAT MAKES IT SO SPECIAL?

This is an exciting mode of learning offered exclusively by Eduvos – and it's the only SAICA-endorsed Self Paced programme in the country!

The DSP mode was created specifically for CTA students. While there are other online and distance programmes offering flexible study options, no other programme comes close to the level of flexibility offered by the Eduvos DSP model.

What is the benefit of the DSP mode?

With DSP mode:

- There's no fixed programme length.
- You study at your own pace and take as long as you need to fully master the concepts.
- You're free to repeat material as many times as needed.
- You only write tests or exams when you feel 100% confident and ready to pass.

So, how does it work?

- With DSP mode, you can start your studies at **any time** during the year and work through the course material and tests at a pace that suits you taking as long as you need to complete the content.
- All course materials, including pre-recorded lecture videos, learning questions, readings, and tests, are uploaded and available to you on demand, online, 365 days a year.
- You'll follow a **structured learning journey**, working step-by-step through each video, example, reading, or learning question one activity at a time.
- While the journey is structured in terms of the order of topics, there is no fixed weekly timetable or lecture schedule. We'll guide you on what to study and how to study – but when you study is entirely up to you!
- You can take as long as you need to master the material and when you're 100% confident and ready, you can book to take the final exam.

How long can I take to finish the course?

We understand that every student is different, and that everyone needs a different amount of time to master the competencies required of a CA(SA). That's why the course is designed to give you the as much time as you uniquely need:

- The **bridging programme** can be completed in as little as 6 months or take up to 18 months if you need more time.
- The **PGDA** offers the flexibility to finish in as little as 12 months but can be extended up to 36 months depending on your pace and availability.

You don't sign up for a fixed programme length. Just start when you're ready, work through the material at your own pace, and write the final exam when you're done. It doesn't matter how long it takes, as long as you finish within the maximum period.

What about tests and exams?

- Tests are written 100% online and can be taken whenever you're ready at any time, on any day, 365 days of the year.
- Once you've completed all coursework and tests, and you feel confident and ready, simply book one of the available final exam opportunities and write the final exam.
- There are three final exam opportunities per year for the **bridging programme**, and two for the **PGDA**.
- You can choose whichever exam date suits you best. You're also free to change to an earlier or later opportunity depending on your progress in the course.

Can you explain more about the multiple exam opportunities?


You may write at any one of the available exam opportunities within your window period. Your window period and final eligible exam date are calculated as follows:

• **Bridging programme** window period = Your enrolment date + 18 months + the next available exam after this date.


• **PGDA** window period = Your enrolment date + 36 months + the next available exam after this date.

The diagram below shows how this works. In this example, you would be eligible to write at any of the exam opportunities shown within the dotted window period:

If you don't feel ready to write, you can revisit any part of the course material as many times as needed. You'll continue to receive support from lecturers throughout. There are no additional fees for extending or changing your exam date – as long as you're within your window period.

HOW IS SELF PACED (DSP) DIFFERENT TO OTHER ONLINE PROGRAMMES?

In both cases all studying takes place 100% online. Self Paced is a form of distance study in which all learning materials are pre-recorded and available on demand via myLMS.

In contrast, **Online Mode** involves **live lectures** delivered via Microsoft Teams according to a **fixed lecture timetable**.

In DSP mode:

- There are **no live classes** and all lecture materials are pre-recorded and available **on demand**, at any time, on any day that suits you.
- Students do not receive a "class schedule" or "study timetable" but rather each student progresses at their **own unique pace**, working through the material when it suits them.

While the materials are hosted online in DSP mode, the **Self Paced format is far** more flexible than any other online programme.

HOW IS SELF PACED (DSP) DIFFERENT TO OTHER DISTANCE PROGRAMMES?

The **Self Paced Mode** allows you to start your studies **on any day of the year**, with the freedom to progress entirely at your own speed.

Unlike traditional distance learning, there are **no fixed weekly study schedules** – so students may be working on different topics at different times.

Every concept is carefully taught through high-quality, **pre-recorded lecture videos** delivered by our expert team of academic Chartered Accountants. These are not just recordings of past lectures – they are **purpose-built videos** designed specifically for Self Paced learning, ensuring structured guidance through the SAICA syllabus.

Also, unlike more "old-fashioned" distance or correspondence courses, you won't receive printed handbooks – **everything is provided online and is available on demand**, in one convenient place.

Self Paced mode is far more flexible than any other distance programme.

SINCE THIS IS A DISTANCE PROGRAMME, WILL I NEED TO JOIN AN ADDITIONAL SUPPORT COURSE?

Absolutely not! While you will need to purchase the prescribed textbooks, we provide a **comprehensive learning experience** that covers every aspect of the SAICA CA(SA) syllabus.

You'll also be **fully supported** by our dedicated team of lecturers who are here to assist you every step of the way. Our learning materials include:

- Specially created pre-recorded lecture videos on every topic
- Detailed lecture notes

WHEN AND WHERE WILL I STUDY?

All studying takes place 100% online via our learning platform, myLMS. You can study any time, on any day that suits your schedule. There is no need to attend a physical campus – although if you prefer, you may choose to write your final exams on campus instead of online. (Please note: all tests are written online from home.)

Eduvos has 12 campuses across the country, and you're welcome to visit your nearest campus to access the library, find a quiet place to study, or meet up with other students to form a study group. But please note that no classes take place on campus.

IF THE COURSE IS SELF PACED, WILL I BE ABLE TO CONTACT THE LECTURERS?

Yes - absolutely!

Even though the programme is Self Paced, it is **not** a **correspondence course**. You are fully supported throughout your academic journey, and our lecturers are here to help.

WHEN CAN I START?

The Self Paced mode offers **official new intakes every 3 weeks** from **January to September**.

However, because the programme is **Self Paced**, you can actually begin studying on **any day of the year** as soon as your **first instalment is paid**.

There are **no official intakes between October and December**, but students who apply during this period will be **pre-enrolled for the next January intake**. If you'd like to get a head start, you'll be given **immediate access to the materials** so you can begin studying before your formal start date and get a head start. Starting early can give you more time to spread out your study load or even finish ahead of schedule.

HOW LONG WILL IT TAKE ME TO FINISH THE CTA?

As this is a Self Paced course, the duration varies from student to student, depending on your unique needs. There is **no fixed programme length**. How long it takes will depend on how much time you're able to commit to studying each week, and how quickly you work through the material.

The table below provides a **rough guide** to how long the course may take, depending on your weekly study time. Every student is different – some may need more time to master the concepts, while others may need less. Please note that **putting in a certain number of hours does not guarantee completion**.

Think of DSP mode as being like a book: You can start reading at any time, read on any day you choose, for as many hours as suits you, and at a speed that suits you. **How long it takes to finish depends entirely on you**.

How much time can you commit to studying each week?	Time track	Study / lecture topics completed each week	Average time to complete the bridging programme	Average time to complete the PGDA
40 - 50 hours	Full time	4 - 5	6 months	12 months

CAN I STUDY PART TIME?

Yes, you can! It's important to understand that while we offer both full-time and part-time payment plans, there is no full time or part time academic plan – all students are enrolled in the same Self Paced programme.

- Full-time students typically commit more hours per week and finish sooner.
- Part-time students commit fewer hours each week and complete the programme over a longer period.
 - o You can refer to the table above to get a better idea of how this works.

We don't force you into a full-time, part-time, or extended-time track. You're free to adjust the number of hours you study each week – **no need to inform us or change your programme registration**.

WHAT HAPPENS IF I'M WORKING AND CAN'T STUDY FOR A PERIOD OF TIME?

Nothing at all. Since the programme is entirely Self Paced, you can take a break **without falling behind**. Simply restart your studies when you're ready – you won't have missed any lectures or test deadlines, and there's no need to notify us. If you still plan to finish in the original time frame, you may need to increase your weekly study time. Alternatively, you can just shift your end date – as long as you finish **within your exam window period**, you're free to progress at your own pace.

DO YOU OFFER A HALFWORK LOAD OPTION?

A "half workload" model refers to taking two of the four modules in the first year, and the other two in the second. While this may sound like a good option, it has significant downsides:

- You must still pass all four modules together at the end of the second year even if you've already passed the first two.
- Many students forget what they've learned in the first year by the time they rewrite the exam, and end up failing modules they had previously passed.
- The second year ends up being harder, not easier, as you are revising old content **and** learning new content at the same time.

For this reason, **we do not offer a half workload model**. Instead, our part-time Self Paced pathway allows you to:

- Study all four modules simultaneously
- Cover fewer study topics each week
- Spread the course over a longer time period

This means your knowledge stays **fresh and up to date**, leading to **better retention** and **better pass rates**.

HOW IS THE CTA PROGRAMME AND COURSE MATERIAL STRUCTURED?

It's important to note that the DSP mode does **not** follow the traditional block or semester system you may be familiar with from undergraduate studies.

The CTA programme is structured into **three levels**, referred to as **CTA1**, **CTA2**, and **CTA3**.

Each level can be completed **flexibly**, typically within **6 to 18 months**, depending on your pace.

Programme Structure:

- CTA1 is a conversion or bridging programme, designed for students who have completed a SAICA AGA(SA) degree or a non-SAICA endorsed bachelor's degree.
- CTA2 and CTA3 are our names for the first and second semesters of the Postgraduate Diploma in Accounting (PGDA).

Students who have already completed a SAICA CA(SA) endorsed bachelor's degree can **skip CTA1** and proceed directly to CTA2.

HOW WILL MY ASSESSMENTS WORK?

Tests

For CTA1, CTA2, and CTA3, **each Part ends with a test in each of the four modules**, typically worth around **40 marks**. These tests always take the form of case study questions.

- Tests are completed **online at home**.
- You can write them on at any time on any day, 365 days of the year that is convenient for you.

Choosing Exam Dates And On Campus Or Online Venues

For CTA1, CTA2, and CTA3, you do not choose an exam date at the start of the course.

- Once you have completed all coursework and written Test 3, you will receive access to a booking form.
- You can then choose:
 - Your exam date
 - o Whether to write online or on campus

CTA1 Exam Structure

- One 80-mark exam per module, in the form of a case study requiring both discussion and calculation. There are no multiple-choice or shortanswer questions
- The exam counts for 100% of your final mark.
- Exams are written over **two consecutive days** in both morning and afternoon sessions:

CTA 1 Exam Dates And Venues

Final exam sessions are available three times per year:

- Late March or early April
- Late July or early August
- November

You may choose to write your exam **online or on campus** (see the note above on how to select your venue).

CTA2 Exam Structure

- The CTA2 exam can be thought of as similar to a mid-year PGDA exam.
- It does **not count towards your final mark**, but is a mock paper to familiarise you with the **SAICA board exam format**.
- The exam mirrors the first SAICA board exam (Initial Assessment of Competence IAC) and consists of **3 integrated case study papers**, each worth 120 marks, written over 3 consecutive days.

CTA2 Exam Dates And Venues

- The CTA2 exam is written online only.
- It can be written on **any day of the year 365 days of the year** whenever you are ready.

CTA3 Exam Structure

- This is the final PGDA exam.
- The exam counts for 100% of your PGDA mark.
- It is written in two parts over two weeks.

Week 1:

- Follows the CTA1 format with an **80-100 mark** case for each module.
- Exams are written over **two days**, with morning and afternoon sessions (*see CTA1 example schedule above*)

Week 2:

- Mirror the CTA2 and SAICA board exam (IAC) format
- Consists of 3 integrated exam papers of 120 marks each, written on three consecutive days (see example CTA2 schedule above)

CTA3 Exam Dates & Venues

There are **two final writing opportunities per year**, timed to align with the SAICA board exam dates:

- November sitting: write the SAICA IAC in January the following year
- Late March or early April sitting: write the SAICA IAC in June of the same year

As with other assessments, you may choose to write online or on campus.

SAICA rules

All exams are conducted under conditions that **mirror the SAICA board exams**. We follow all **SAICA exam regulations** to prepare you for the real board assessment environment.

IF I DON'T PASS ON MY FIRST ATTEMPT BUT I'M STILL WITHIN THE WINDOW PERIOD CAN I TRY AGAIN?

Yes you can write at the next opportunity! The second opportunity **can still be taken even outside** of your window period. You just need to ensure that you meet the conditions and minimum mark required to qualify for a second attempt – see details below

HOW DO I OUALIFY FOR A SUPPLEMENTARY EXAMS?

We prefer the term "second opportunity" to "supplementary exam".

After every exam the lecturers review the level of difficulty and will set a second opportunity **threshold mark**. If you don't pass on your first attempt but your marks are above the threshold you will be you will be eligible to write again at the **next** exam session.

- This gives you several months to prepare properly for a successful attempt.
- There is a nominal fee charged to cover the administration of enrolling you
 into the next opportunity and to cover the cost of marking of the second
 exam, but there are no additional tuition fees charged.
- You will continue to have full access to all course materials and support from the lecturers while preparing.
- The second opportunity can still be taken even outside of your window period.

WHAT ARE THE PGDA ENTRANCE REOUIREMENTS?

To be admitted to the **Postgraduate Diploma in Accounting (PGDA)**, you must hold one of the following:

- A SAICA CA(SA)-endorsed bachelor's degree (or equivalent), or
- A SAICA CA(SA)-endorsed bridging qualification, or
- A SAICA-recognised **postgraduate bridging programme**, such as:
 - o The Eduvos CTA1; Milpark, IAS, or UJ BCTA

WHAT ARE THE CTA1 ENTRANCE REQUIREMENTS?

To be admitted to the CTA1 Bridging Programme, you must hold either:

- A SAICA AGA(SA)-endorsed bachelor's degree (or equivalent), or
- A non-SAICA-endorsed degree that includes the following modules:
 - o Financial Accounting 1, 2, and 3
 - Exposure to Management Accounting or Cost Accounting at secondyear level or higher
 - o Financial Management at third-year level or higher
 - (Note: Management Accounting is often taught as part of a Financial Management module)
 - Auditing 2 and 3
 - o Taxation 2 and 3
 - o Governance, Strategy, and Risk at third-year level

Exceptional Entry Path

In some cases the requirements for Auditing, Taxation, and Governance may be **partially waived** based on the student's prior academic background and experience. In these cases, students need only have completed:

- Auditing 2 or
- Taxation 2

WHAT IF MY OUALIFICATION DOESN'T MEET THESE REOUIREMENTS?

If you do **not yet meet the requirements for CTA2**, you may be offered a place on the CTA1 Bridging Programme.

If your bachelor's degree does **not meet the CTA1 entry criteria**, you may be required to:

- Enrol for selected undergraduate modules for non-degree purposes, or
- Register for the BCom in Accounting at Eduvos and apply for credit recognition for previously completed modules

The **minimum entry requirement** for the CTA1 Bridging Programme is an NQF Level 7 qualification (Bachelor's Degree or Advanced Diploma). Therefore students with a **National Diploma** must enrol in the BCom in Accounting and may also apply for module credits.

Step 2: Submit Your Formal Enrolment Application

Once you have received your preliminary acceptance in Step 1, you can proceed to complete the formal enrolment application at: www.eduvos.com/apply-now/

When enrolling you will need to:

- Upload your preliminary acceptance letter
- Upload your latest tertiary transcripts
- Upload a copy of your ID
- Pay the R300 application fee (the fee confirms your place on the programme subject to final approval of your transcripts)

WHY IS THERE AN APPLICATION FEE?

There is **no fee** for completing the preliminary offer of acceptance form – we strongly recommend completing this first to confirm that you meet the entry criteria.

Once you proceed to the **formal application**, the R300 fee **guarantees** your place on the programme provided the information in the enrolment application matches the preliminary information you shared.

Please note: Your application **will not be processed** until the application fee has been paid, and you will not receive any communication from Eduvos. Even if you have received a preliminary offer of acceptance, your place is not guaranteed until the fee is paid and your documents are submitted.
